



FLOOR DISCUSSION PROCEDURES

- 1 PRESIDING OFFICER WILL ASK FOR 2 DELEGATES TO SPEAK IN FAVOR OF THE MOTION
- **DELEGATES TO SPEAK IN FAVOR RAISE THEIR HANDS** AND THE PRESIDING OFFICER WILL ADD 2 TO THE SPEAKERS LIST
- 3 PRESIDING OFFICER WILL ASK FOR 3 DELEGATES TO SPEAK AGAINST THE MOTION
- **DELEGATES TO SPEAK AGAINST RAISE THEIR HANDS** AND THE PRESIDING OFFICER WILL ADD 3 TO THE SPEAKERS LIST
- 5 MAKER OF MOTION SPEAKS IN FAVOR OF THE MOTION FIRST
- REMAINING **SPEAKERS WILL ALTERNATE BETWEEN CON AND PRO SPEAKERS** UNTIL ALL (UP TO SIX) HAVE SPOKEN




VOTING PROCEDURES

'YES' VOTES WILL BE CALLED FIRST

- 30 SECONDS TO RAISE YOUR HAND TO VOTE YES
- LEAVE YOUR HAND RAISED
- STAFF WILL LOWER ALL HANDS
- 'NO' VOTES WILL BE CALLED SECOND
 - 30 SECONDS TO RAISE YOUR HAND TO VOTE NO
 - LEAVE YOUR HAND RAISED
 - STAFF WILL LOWER ALL HANDS
- VOTE COUNTERS WILL ARCHIVE THE RESULTS OF EACH VOTE FOR THE RECORD, AND THE RESULTS OF THE VOTE WILL THEN BE ANNOUNCED

CONSENT CALENDAR

A consent calendar is a practice that groups a number of items/actions into one agenda item. The consent calendar can be approved in one action, rather than filing motions on each item separately.

If a member disagrees with a consent calendar item or wishes to amend a consent calendar item, the member would request that the item be pulled from the consent calendar.

The chair would ask if the members are in favor of approving the consent calendar minus the pulled item(s), pause for objections, and then adopt.

FLOOR PROCEDURES FOR CONSENT CALENDAR VOTES

- 1 CONSENT CALENDAR INTRODUCED
- **DELEGATES PULL BILLS OR RESOLUTIONS** FOR FURTHER DISCUSSION
- APPROVE REMAINING ITEMS
 ON CONSENT CALENDAR
- EACH PULLED BILL OR
 RESOLUTION WILL BE
 ADDRESSED ONE AT A TIME
 BY THE PRESIDING OFFICER
 WITH A MOTION,
 DISCUSSION, AND VOTE

VOTING PROCEDURES

1

'YES' VOTES WILL BE CALLED FIRST

- **30 SECONDS TO RAISE YOUR HAND** TO VOTE YES
- LEAVE YOUR HAND RAISED UNTIL WE CLEAR THE VOTE (DO NOT LOWER YOUR HAND)

2


'NO' VOTES WILL BE CALLED SECOND

- 30 SECONDS TO RAISE YOUR HAND TO VOTE NO
- LEAVE YOUR HAND RAISED UNTIL WE CLEAR THE VOTE (DO NOT LOWER YOUR HAND)
- VOTE COUNTERS WILL ARCHIVE THE RESULTS OF EACH VOTE FOR THE PERMANENT RECORD, AND THE RESULTS OF THE VOTE WILL THEN BE ANNOUNCED

FLOOR DISCUSSION PROCEDURES

- 1 PRESIDING OFFICER WILL ASK FOR 2 DELEGATES TO SPEAK IN FAVOR OF THE MOTION
- **DELEGATES TO SPEAK IN FAVOR RAISE THEIR HANDS** AND THE PRESIDING OFFICER WILL ADD 2 TO THE SPEAKERS LIST
- 3 PRESIDING OFFICER WILL ASK FOR 3 DELEGATES TO SPEAK AGAINST THE MOTION
- **DELEGATES TO SPEAK AGAINST RAISE THEIR HANDS** AND THE PRESIDING OFFICER WILL ADD 3 TO THE SPEAKERS LIST
- 5 MAKER OF MOTION SPEAKS IN FAVOR OF THE MOTION FIRST
- REMAINING **SPEAKERS WILL ALTERNATE BETWEEN CON AND PRO SPEAKERS** UNTIL ALL (UP TO SIX) HAVE SPOKEN


