Subject: 2023 Statewide Officer and Regional Director Elections

Statewide Officers are elected for a four (4) year term, and Regional Directors are elected for a two (2) year term. Please refer to Article III of the CDP By-Laws for further information regarding the election of officers and Officer job descriptions.

At the 2023 May Organizing Convention, Delegates will vote to elect a new CADEM Secretary and Controller (Secretary is currently an interim appointment, and Controller is vacant) and elect Regional Directors for a two (2) year term in the NEW reapportioned CADEM regions. 1. FILING REQUIREMENTS

Filing requirements for Statewide Office and Regional Director, per Party By-laws Article III, Section 3. a: Election of Officers 2023, are as follows:

A Notice of Intent-to-Run Declaration must be filed by a member of this Committee by 5 PM on Wednesday, May 17, 2023, to be a candidate for any Statewide or Regional Director Office, and considered as a nomination for that particular office.

You must be a 2023-2025 Democratic State Central Committee (DSCC) member to run for any office.

2. TIMELINE

Candidate Filing Period Opens - April 4th at 12 PM Noon

Candidate Filing Period Closes - May 17th at 5 PM

Controller, Secretary, and Regional Director Election - Saturday, May 27th, from 5 PM to 7 PM

Regional Director Orientation - Sunday, May 28th, from 8:30 AM to 9:30 AM

If necessary:

Runoff Elections for Controller, Secretary, and Regional Directors - May 28th at 8 AM

3. CONTESTED ELECTIONS AND RUNOFFS

If no candidate in a contest for a Statewide Officer Vacancy or a Regional Director position receives a majority vote, then a runoff election shall be held Sunday morning. If the runoff election includes one for a Statewide Officer position, all runoff elections will be held from 8 AM to 10 AM. In the event that only Regional Director Runoffs are necessary, then the election will be held from 8 AM to 9 AM.

5. DISTRIBUTION OF MATERIALS/SIGNS - RULES

If you would like volunteers to distribute signage during Saturday or Sunday General Session, you must have your volunteers deliver and distribute them during the sessions. Those volunteers must be credentialed to access Hall A/B at the Los Angeles Convention Center, 1201 South Figueroa Street, Los Angeles, California 90015. All signs must be dropped off at the Convention Center Hall A/B by 5 PM Friday, May 26, 2023.

All signs MUST carry the Union label and cannot be larger than 22x14 inches landscape or 11x17 inches portrait.

Please contact Emma Harper at 916-949-3868 on-site by May 26, 2023, at 5 PM, to help you organize and store the signs for Saturday or Sunday General Session in the back of the Hall near the press riser.
