## BROWNIE MARY DEMOCRATS OF CALIFORNIA REPORT

### 2025 SATEMENT OF PURPOSE

The purpose of the Brownie Mary Democrats of California is to:

- Promote the Democratic Party and the election of Democrats to office on the federal, state and local level
- Promote the implementation of Prop. 64 so that access to cannabis is safe, reliable, local and affordable
- Repeal cannabis prohibition on the federal level
- · Protect the rights of medical marijuana patients,
- End the futile, racist, inhumane and extortionate War on Drugs
- Engage with youth and Independents who are a growing segment of Americans for whom cannabis legalization is a critical issue and encourage them to register as Democrats and become active in the Party.

### **GOALS 2024 REVIEWED**

- Promote the Democratic Party and the election of Democrats to office on the federal, state and local level
  - BMD members participated on the local levels as members of their Counties Democratic Central Committees, donated time and money to the election of Democrats, wrote letters and OPEDs to local media, participated in podcasts and social media to promote the election of Democrats and volunteered to staff tables to register new Democrats. BMD worked with CaNORML to include Democratic candidates in their voter guides distributed to cannabis consumers throughout California.
- Promote the implementation of Prop. 64 so that access to cannabis is safe, reliable, local and affordable
  - Contacted state officials on legislation such as AB 1775 which allows cannabis dispensaries to provide and sell non-alcoholic beverages, food and sell tickets and collect cover charges for entertainment like bars and taverns do and other state legislation affecting taxes and distribution of cannabis, AB 2555 which extends the provision of medical cannabis to financially challenged patients for another 5 years, SB 1059 which ended the double taxation of cannabis and other bills. Worked on the local level to get local city and county elected officials such as Oakland, Cathedral City, Eureka, Lompoc, Palm Springs, Sacramento Area (Isleton), San Francisco, South Lake Tahoe, Weed, West Hollywood and others to allow for the operation of cannabis lounges as permitted under AB 1775.
- Repeal cannabis prohibition on the federal level by contacting Congressional
  officers in support of removing cannabis from the schedule of Controlled
  Substances. President Biden's bid to remove cannabis from its current listing of
  Schedule 1 to Schedule 3 was also supported although the complete removal of
  cannabis, like alcohol and tobacco from the Schedule of Controlled Substances
  is the eventual goal.
- Protect the rights of medical marijuana patients by reducing taxes on cannabis purchased by legal medical marijuana patients and also the passage of AB 2555 which allows cannabis that is provided free to patients to be exempt from taxation.
- End the futile, racist, inhumane and extortionate War on Drugs by working with local and state officials to change laws to eliminate arrest, prosecution and imprisonment of low-level non-violent drug offenders. President Biden did issue pardons to thousands of non-violent drug offenders in federal prisons. Brownie Mary Democrats succeeded in passing a resolution calling for the decriminalization of personal possession of small amount of drugs.
- Engage with youth and Independents who are a growing segment of Americans
  for whom cannabis legalization is a critical issue and encourage them to register
  as Democrats and become active in the Party. BMD members spoke at civic
  organizations and college campuses about cannabis law reform and encouraged
  attendees to register as Democrats pointing out that it was the support of the
  Democratic Party that helped pass Prop. 64 which legalized cannabis for all adult

### **2025 GOALS**

Increase Democratic voter registration by placing voter registration forms at dispensaries along with Brownie Mary Democrats membership forms leading to an increase in BMD memberships.

Increase access to safe, reliable, local and affordable cannabis by working with community organizations, local government agencies and elected Democratic officeholders leading to cannabis consumers reporting easier access and affordability.

Work with state legislators to increase access to cannabis by passing legislation preventing local governments from passing bans to prevent cannabis cultivation, manufacture and distribution leading to an increase in the percentage of cities and counties allowing cannabis businesses to operate legally and openly which will lead to a decrease in illegal sales and cultivation.

Work with state and local legislators to streamline the application process for cannabis business licenses, revise regulations to they are more rational and reasonable and reduce taxation so that cannabis taxes will be comparable to the taxes on wine leading to cannabis businesses being fiscally sound and a reduction in competition from illegal sources.

Work with California's congressional delegation to end federal cannabis prohibition leading to having cannabis removed completely from the Schedule of Controlled Substances thereby allowing banks to process money from cannabis businesses and the release of prisoners from federal prison for marijuana offenses and having their records expunged.

Support Democratic candidates by raising funds for their campaigns by encouraging cannabis consumers to support them financially and with their votes leading to Democratic candidates receiving contributions from cannabis consumers and businesses and gaining additional votes leading to the election of more Democrats to office.
