**In order to vote and have one's vote counted at this Executive Board Meeting, an Executive Board member must be fully credentialed by having timely (1) paid or waived (requested in writing by the delegate) both their 2026 DSCC Dues and July Executive Board Registration fees, (2) obtained their credential prior to the close of credentialing. Once registered the member must (3) complete and return to the proper authority any ballot that may be issued and (4) agree to abide by the Code of Conduct.*

***Executive Board voting eligibility requires EBoard members and proxies to settle annual DSCC delegate dues. For proxy pre-approval, the EBoard member must register and submit the finalized proxy form by **Friday, July 17th, at 5:00 PM**. Only DSCC members may request dues and registration fee waivers. EBoard registration covers the proxy; no separate registration is required.*
